OPTIONAL ADDITIONAL CLASSES:

- 1. For 10th and 11th grade students who will be taking the new Digital PSAT in October and for 12th grade students who may want to try the Digital SAT in Spring 2024, there will be two optional additional Zoom-only classes focused on applying the course lessons to the digital versions of the exams. Tuition for the two additional sessions will be \$30 total. Tentative dates are Wed Sept 27 (7:00 ~ 8:30 pm) and Sun Oct 8 (4:00 ~ 5:30 pm). Details will be discussed in August.
- 2. About once every six classes, an extra no-charge Zoom-based Q&A session will be offered on a weekday evening for students who would like additional assistance in understanding specific lessons. This helps to ensure that no student feels left behind in lessons about which they are confused.

This course prepares for the October 2023 SAT, ACT & PSAT exams; students are encouraged to take additional SAT & ACT exams along the way, including taking advantage of any "school day" testing opportunities offered by their respective schools. For students who plan to also take the SAT or ACT again in later months, private and small group follow-up classes may be arrangeable (schedule permitting).

IMPORTANT NOTES: Tuition for the course must be remitted in full before the first day of the course and is non-refundable once the course begins...deposits are non-refundable. Students will be required to purchase the latest versions of "The Official ACT Prep Guide" and "The Official SAT Study Guide". Homework & proper behavior are essential; students who repeatedly come to class unprepared or who disrupt class may be sent home. Use of cell phones during class is prohibited except when Dr. Rothkopf asks students to use their phones to send pictures of homework assignments. We reserve the right to switch to Zoom-only in the event of a public health emergency.
